What is Skills First funding?

Skills First is a Victorian Government program that provides access to government-subsidised training for courses in growth industries. If you are eligible, your tuition fees will be lower.

Am I eligible?

From 1 January 2024, you need to meet these requirements to be eligible for Skills First subsidised training:

Citizenship

You must be:

- an Australian citizen, or
- an Australian permanent resident, or
- a New Zealand citizen.

Physical location

You must be physically present in Victoria or a border region while participating in training and assessment.

Course limits

Skills First funding is limited to:

- two courses at a time
- two courses in a year
